Dear Mr. Fields,

This letter is to set the terms on which the Trustees of Public Trust agree to hold the Richard "Dick" Michelson Scholarship Fund, which I'd like to establish.

- 1. The Trustees will hold and invest the fund as part of the Endowment Fund administered by them for the benefit of the Town of Lexington.
- 2. Each year the fund will transfer to the Lexington Scholarship Committee of their designated successor, ¾ of the annual net income.
- 3. ¼ of the annual net income and all capital gains shall be transferred to the principal.
- 4. Each year the Lexington Scholarship Committee shall award one or more scholarships to be known as the Richard "Dick" Michelson Scholarship. To be eligible the recipient must meet the following criteria:
 - a. Be a graduate of Lexington High School or Minuteman Technical High School;
 - b. Have demonstrated the skills and the initiative to merit higher education, which may be a two or four year college program or a one or two year technical program;
 - c. Demonstrate financial need;
 - d. Have demonstrated a respect for Lexington as a "community";
 - e. Every effort should be made to give equal consideration to graduates of both schools.
- 5. The Lexington Scholarship Committee shall allow a member of the Michelson family, as long as they are willing and able to serve, to present the scholarship to the recipient at the annual awards night.

Dear Board Members.

The Lexington Retailers Association (LRA) requests permission to have exclusive use of the Muzzey St./ Waltham St. parking lot on Saturday May 26, 2018 (with a rain date of June 3) from 5 a.m. to 5 p.m., for the purpose of hosting the 39rd annual **Discovery Day Street Fair**. In addition we request the use of Emery Park, from 3:00 p.m. to 6 p.m. for an **Outdoor Concert** by a local band playing family oriented music.

During Discovery Day the LRA will be placing portable toilet facilities in the Waltham/Muzzey St. parking lot, and temporarily convert the parking spaces at either entrance to handicapped parking for the duration of the event. We also want to work with the DPW to provide temporary bike racks for the event.

For the purpose of event publicity we request permission to:

-erect seven temporary signs at the following locations:

- 1) on Emery Park, starting May 11 and ending at the conclusion of the event;
- 2) on Massachusetts Avenue sidewalk near the Police Booth, during the event;
- 3) on Massachusetts Avenue sidewalk at Waltham Street, during the event;
- 4) on Massachusetts Avenue sidewalk at Muzzey Street, during the event;
- 5) on Massachusetts Avenue sidewalk at the Alley between #'s 1776-1780, during the event,
- 6) on Waltham Street sidewalk at the Alley between #'s 11-25, during the event;
- 7) at the Bike-path, in the area by the crossover behind 1775 Mass Ave, during the event.

-park a flat bed trailer in Lexington Center on Massachusetts Avenue in two metered parking spaces in front of Depot Square starting on Friday May 18 and ending on the morning of Discovery Day. A banner publicizing Discovery Day would be hung on the trailer.

-provide Free parking at the Central Business District parking meters, and not charge for parking in the Depot Lot on Discovery Day. In the past the LRA covered the meters with a bag which publicized the free parking and the event. They would be attached late in the evening prior to Discovery Day and removed after the event. The bags work in conjunction with the above sidewalk signs. We understand using these old bags could harm the new meters, but would like to continue this publicity. We would work with the Parking Management Group to develop an appropriate method.

Last year, over 80 of Lexington's businesses, civic organizations and municipal departments transformed the Waltham /Muzzey St. parking lot into a fun filled, family oriented street fair. We appreciate the cooperation the Town provided last year, and look forward to working with you again.

Q & A - Discovery Day 2018 - Saturday May 26

Q. What will occur during Discovery Day?

A. Discovery Day consist of two events located in different venues. There is a street fair in the Waltham St/Muzzey St parking lot and an outdoor concert in Emery Park.

Q. How will the Muzzey St./ Waltham St. parking lot be used?

A. The parking lot will be closed to all vehicular traffic at Muzzey Street and Waltham Street, parking will be prohibited, and a pedestrian mall will be created. Participants will be assigned specific locations. The following is a tentative schedule:

5 a.m. Close the parking lot to public vehicular traffic

Participants begin set-up

10 a.m. Participants open to public 3 p.m. Participants close to public

Participants breakdown and cleanup

5 p.m. Parking lot reopened to public vehicular traffic

Q. Who will be allowed to participate?

A. Lexington retail and service businesses; Lexington community organizations; and Town of Lexington departments and committees

Q. What will occur at the street fair?

The Participants will be allowed to conduct the following activities:

<u>Businesses</u> - promote their businesses and sell merchandise

<u>Community organizations</u> - promote their organization (fundraise with LRA approval)

<u>Town Departments/Committees</u> – promote their groups (fundraise with LRA approval)

In addition, the LRA will provide family oriented entertainment in the parking lot. This may include, but may not be limited to live music performances and live dancing performances.

Q. What is happening in Emery Park?

A. A family oriented outdoor concert from 3:30 p.m to 6 p.m. In the past the *Nowheremen*, a Lexington based Beatles cover band performed. But at this time we have not yet hired a band.

Q. What will the charges be to participate?

A. Charges will be assessed to cover the expenses involved in promoting and implementing Discovery Day. Those expenses will include mailings, advertising, entertainment, rental costs, and town services, as examples. Businesses will be charged a set fee to participate. Lexington community organizations will be charged a highly discounted nominal fee, and Town of Lexington departments and committees will be allowed to participate for free.

Q. What town services will be required?

A. As in the past, we will work with the Police Department for detail officers required for closing the lot for the event. In addition, the DPW assists with site set-up, recycling and rubbish bins, trash disposal and site cleanup. We will again pay the costs for LEXPRESS to operate during the event allowing the public to ride for free.

A Special Event Permit application has been filed with the Town Managers office in conjunction with this request.

Planning Meetings - The support and cooperation of the Town of Lexington has always been a key factor in our success and we hereby respectfully request your approval for our schedule above. Upon approval, we will have a formal event planning meeting with the

Town Departments. Subsequent meetings will also be held with key Departments on as the event approaches.

Lighting – Fiesta Shows will be providing all lighting sources. We are requesting that lights be allowed to be used if necessary until 11:30PM on Monday, July 2nd, during setup and until 11:30PM after the daily closing of the Carnival July 3rd - July 7th to allow carnival guests an opportunity to leave the area safely.

Fireworks - The Lexington Lions Club requests permission to have a fireworks display on Thursday, July 5, 2018 at approximating 9:30 PM subject to approval of the fireworks vendor, Atlas PyroVision Productions, Inc. and safety precautions by the Fire Department.

Living Quarters and On-Site Supervisor - The Fiesta Shows carnival workers will occupy living quarters (i.e., trailers) located near the Lexington High School Field House in cooperation with the Department of Public Facilities. They will act in accordance with the conditions set forth in prior years including Fiesta Shows identifying (by name and cell phone number) an on-site supervisor who will be the primary contact person for the Lexington Police Department on any matters regarding carnival staff. This supervisor will be on-site and available between the hours of midnight and 8:00 a.m. There will be no living quarters at Hastings Park.

Overnight Police Detail and Alcohol Consumption – The Lexington Lions Club will arrange and pay for a Lexington Police Department security detail between the hours of midnight and 8:00 a.m. for each night the carnival is in Town and will work with the Police Department and follow their recommendations. Dean & Flynn, Inc. DBA Fiesta Shows agree that there is no consumption of alcoholic beverages on public property.

Break Bottle Game –There will not be a break bottle game at Hastings Park.

Backflow Preventer – The Lexington Lions Club will be responsible for making a \$1,000 deposit for a backflow preventer valve from the Department of Public Works.

Post-Carnival Meetings – The Lexington Lions Club will plan to hold a post-carnival meeting with the DPW on Monday, July 9th at Hastings Park to review the conditions of the grass at Hastings Park. Lions and Fiesta shows will be responsible for any and all repairs to the grass. Another debriefing meeting will be held within 2 months after the Carnival including all appropriate Town Departments to review the carnival layout, and any concerns that may have come up during the carnival.



To see if the Town will vote to make supplementary appropriations, to be used in conjunction with money appropriated under Articles 4, 5, 9 and 10 of the warrant for the 2017 Annual Town Meeting, to be used during the current fiscal year, or make any other adjustments to the current fiscal year budgets and appropriations that may be necessary; to determine whether the money shall be provided by transfer from available funds including Community Preservation Fund; or act in any other manner in relation thereto.

(Inserted by the Board of Selectmen)

FUNDS REQUESTED: unknown at press time

DESCRIPTION: This is an annual article to permit adjustments to current fiscal year (FY2018) appropriations.

ARTICLE 30 APPROPRIATE FOR AUTHORIZED CAPITAL IMPROVEMENTS

To see if the Town will vote to make supplementary appropriations to be used in conjunction with money appropriated in prior years for the installation or construction of water mains, sewers and sewerage systems, drains, streets, buildings, recreational facilities or other capital improvements and equipment that have heretofore been authorized; determine whether the money shall be provided by the tax levy, by transfer from the balances in other articles, by transfer from available funds, including enterprise funds and the Community Preservation Fund, by borrowing, or by any combination of these methods; or act in any other manner in relation thereto.

(*Inserted by the Board of Selectmen*)

FUNDS REQUESTED: unknown at press time

DESCRIPTION: This is an annual article to request funds to supplement existing appropriations for certain capital projects in light of revised cost estimates that exceed such appropriations.

ARTICLE 31 AMEND GENERAL BYLAW REGARDING FINANCIAL COMMITTEES (Citizen Article)

To see if the Town will vote to update its General By-Laws related to the Appropriate Committee and the Capital Expenditures Committee to reflect current practice, consistent with state law and Lexington's Selectmen-Town Manager Act, or act in any other manner in relation thereto.

(Inserted by David Kanter and 9 or more registered voters)

DESCRIPTION: This Article proposes updates to the General By-Laws to more accurately reflect the two finance committees' activities and responsibilities throughout the year, including at all Town Meetings.

ARTICLE 32 AMEND TOWN BYLAW: BAN PLASTIC BAGS (Citizen Article)

To see whether the Town will vote to amend the Town Bylaws of the Town of Lexington to ban the use of thin-film single-use plastic bags, or to act in any manner in relation thereto. The purpose of this bylaw is to ban the use of thin-film (less than 4.0 mil) single-use plastic checkout bags by business establishments in the town of Lexington.

(Inserted by Janet Moran and at least 9 or more registered voters)

DESCRIPTION: This Article bans the use of thin-film single-use plastics bags. These bags have a detrimental impact on the environment by blocking waterways and sewer systems; choking, poisoning and entangling wildlife and collecting in our bodies interfering with critical bio-functioning. This ban does not include bags for laundry, dry cleaning, newspapers, loose produce, pastry, or for wrapping frozen food, fish, or meat. Customers are encouraged to bring reusable bags.

ARTICLE 33 TO MAKE LEXINGTON A "WELCOMING, INCLUSIVE, SAFE COMMUNITY" (Citizen Article)

To see if the town will vote to amend Part 1 of the general bylaws to include a chapter regarding the rights and relationships between town employees (including their agents) and undocumented immigrants, or act in any other manner relation thereto.

(*Inserted by Todd Burger and 9 or more registered voters*)

DESCRIPTION: The intent of this article is to make Lexington a more welcoming, inclusive & safe community for immigrants, regardless of immigration status. The article seeks to establish safeguards that adhere to the principles set forth in the Safe Communities Act (SCA), Senate Bill # 1305, now before our state legislature. The SCA's co-sponsors include State Representative Jay Kaufman, State Senator Mike Barrett and State Senator Cindy Friedman. Our proposed Lexington warrant article would give immigrants living, working or traveling through Lexington the confidence that they could approach police or other town officials for help of any manner, without threat of their immigration status being used against them in any way. Because that is not currently the case, the entire community is at risk, when a segment of the population is afraid to reach out for help.

ARTICLE 34 RESOLUTION TO REQUEST WARRANT ARTICLES TO BE ACCOMPANIED BY FINANCIAL PROJECTIONS (Citizen Article)

To see if the Town will vote to pass a resolution strongly encouraging authors of warrant articles to present accompanying data with their motions showing the expected financial impact of their motion along with explicit assumptions to facilitate the evaluation of their motion by town meeting, or act in any other manner in relation thereto.

(Inserted by Mark Anderson and 9 or more registered voters)

DESCRIPTION: The purpose of this resolution is to establish an expectation that warrant articles should be presented with reasonably standard impact statements so town meeting members can quickly and more completely assess related motions.

ARTICLE 35 AMEND GENERAL BYLAWS TO REPEAL PROHIBITION OF RECREATIONAL MARIJUANA ESTABLISHMENTS IN TOWN (Citizen Article)

To see if the Town will amend the general bylaws to repeal the prohibition of Recreational Marijuana Establishments in town; establish, create, adopt, and/or amend general Marijuana bylaws, including for Medical Marijuana and Recreational Marijuana; or act in any other manner in relation thereto.

(*Inserted by Ethan Handwerker and 9 or more other registered voters*)

DESCRIPTION: This article seeks to amend the general bylaws to repeal the prohibition of recreational marijuana establishments in town.

Article 36 ACCEPT MGL CHAPTER 59, CLAUSE 5C ½

To see if the Town will vote to accept Section 5C ½ of Chapter 59 of the Massachusetts General Law relating to additional tax exemptions; or act in any other manner in relation thereto.

(Inserted by the Board of Selectmen)

DESCRIPTION: Clause 5C ½ allows the Town, by vote of Town Meeting, to increase the benefit amount of all personal property tax exemptions by any percentage up to 100%. This additional exemption is applied uniformly to all personal property tax exemptions and cannot be applied selectively.

ARTICLE 37 RE-ZONING 331 CONCORD AVE (Property Owner)

To see if the Town votes to amend the Code of the Town of Lexington, Zoning Bylaw Sections and the Zoning Map of the Town of Lexington, by changing the zoning district designation of the land described in a certain written metes and bounds description and certain plans on file with the Planning Board, from the current RO One Family Dwelling District to a PD Planned Development District, said property being commonly known as Town of Lexington Assessors' Map 5 Parcels 19C, 20, 21A at 960-990 Waltham Street, in order to allow the construction of a new building on the property of approximately 119,000 square feet, together with parking and other improvements, to be known as Brookhaven at Lexington; and to add it to the adjoining RD Planned Residential District Brookhaven at Lexington at 990-1010 Waltham Street as one composite PD Planned Development District and to approve the preliminary site development and use plan entitled "Preliminary Site Development and Use Plan for the RD Planned Residential District at 960-1010 Waltham Street, Lexington," ("the PSDUP") on file with Lexington Town Clerk and Lexington Planning Board for said parcels, and to approve standards for development, uses permitted, dimensional standards and other provisions contained within the PSDUP, or to act in any other manner relative thereto.

(Inserted by RLR Realty Trust, Richard Cannizzo, Trustee)

DESCRIPTION: The article requests rezoning and approval of a Preliminary Site Development and Use Plan. The general location of the property is shown on a plan entitled: "Site Development Plan Set, LCB Senior Living, #331 Concord Avenue, Lexington, MA 02421," dated December 18, 2017, prepared by Allen & Major Associates, Inc. which is on file with the Lexington Town Clerk and the Lexington Planning Board.

ARTICLE 38 AMEND ZONING BYLAW AND MAP IN COMMERCIAL

DISTRICT/MARRETT RD (Citizen Article)

To see if the Town will vote to amend the Zoning Bylaw and Map to allow additional uses and density in the commercial district along Marrett Road near Spring Street by creating a new zoning district replacing the existing CN and CS districts; or act in any other manner in relation thereto.

(Inserted by Charles Minasian and 9 or more registered voters)

DESCRIPTION: There are seven parcels on both sides of Marrett Road near Spring Street. The northern parcels are in the CN zone and across the street the southern parcels are in the CS zone. The allowed uses are inconsistent between the two sides of the street. A new zoning district will better meet the needs of the surrounding neighborhood and unify these small commercial districts.

This article would replace the current CN and CS commercial districts along Marrett Road near Spring Street with a new district reflecting modern commercial zoning practices, allowing more flexible uses, and allowing increased density.

ARTICLE 39 AMEND GENERAL BYLAWPIERCE-LOCKWOOD NEIGHBORHOOD CONSERVATION DISTRICT

To see if the Town will vote to amend the Code of the of the Town of Lexington by adding a new Chapter 78B entitled "Pierce-Lockwood Neighborhood Conservation District," or take any other action in relation thereto.

(Inserted by the Board of Selectmen at the request of the Planning Board and Historical Commission)

DESCRIPTION: This Article would create a neighborhood conservation district, as authorized by Chapter 78 of Town's Code, to be known as the Pierce-Lockwood Neighborhood Conservation District. NCDs are designed to protect such area's "architectural, aesthetic, cultural, political, economic, social and/or historical qualities" or "the cohesiveness of the NCD Area in terms of scale, size, and type of construction, materials, style or age." The findings of the Pierce-Lockwood study report are that the neighborhood fully meets both the criteria of significance and cohesiveness, resulting in a strong qualification for the designation of a Neighborhood Conservation District. As required by Chapter 78, all properties subject to regulation under this proposed bylaw were afforded the opportunity to opt-out of the district.

ARTICLE 40 AMEND GENERAL BYLAWS TURNING MILL NEIGHBORHOOD CONSERVATION DISTRICT

To see if the Town will vote to amend the Code of the of the Town of Lexington by adding a new Chapter 78A entitled "Turning Mill Neighborhood Conservation District," or take any other action in relation thereto.

(Inserted by the Board of Selectmen at the request of the Planning Board and Historical Commission)

DESCRIPTION: This article would create a neighborhood conservation district, as authorized by Chapter 78 of Town's Code, to be known as the Turning Mill Neighborhood Conservation District. NCDs are designed to protect such area's "architectural, aesthetic, cultural, political, economic, social and/or historical qualities" or "the cohesiveness of the NCD Area in terms of scale, size, and type of construction, materials, style or age." The findings of the Turning Mill study report are that the neighborhood fully meets both the criteria of significance and cohesiveness, resulting in a strong qualification for the designation of a Neighborhood Conservation District. As required by Chapter 78, all properties subject to regulation under this proposed bylaw were afforded the opportunity to opt-out of the district.

ARTICLE 41 WRIGHT FARM PARCEL SPLIT (241 GROVE STREET)

To see if the Town will vote to adjust the lot split of the property at 241 Grove Street, on Lexington Assessor's Map 91, Lot 1C previously voted by Annual Town Meeting in 2014, for conveyance to the Conservation Commission and LexHab; or act in any other manner in relation thereto.

(Inserted by the Board of Selectmen at the request of LexHAB)

DESCRIPTION: This article requests a revised rear lot line for the conveyance of land to the Conservation Commission and to LexHab, respectively, at 241 Grove Street, previously voted by Article 9 of Annual Town Meeting 2014, to provide a more regularly-shaped back yard for the affordable house.

ARTICLE 42 AMEND ZONING BYLAW FOR SPECIAL PERMITS (Citizen Article)

To see if the Town will vote to amend the Zoning Bylaw to alter the rules for special permit residential developments to require affordable and age restricted housing; to limit the developable site area, unit size, and number of units allowed; and to set the standards for the preservation of environmental features and other site attributes; or to act any other manner in relations thereto

(Inserted by Matthew Daggett and 9 or more registered voters)

DESCRIPTION: This article proposes revisions to the regulation of discretionary special permit residential developments, authorized under § Section 6.9 of the Zoning Bylaw. The intent of the proposal is to amend the Bylaw to better address specific residential development needs in Lexington that are not being met by the current regulatory framework.

ARTICLE 43 AMEND CHAPTER 135 ZONING BYLAW (Citizen Article)

To see if the Town will vote to amend Chapter 135 of the Zoning Bylaw to zone for Medical Marijuana Cultivation Centers, Medical Marijuana Processing Centers, Medical Marijuana Distribution Centers, and/or Recreational Marijuana Establishments; or act in any other manner in relation thereto.

(Inserted by Ethan Handwerker and 9 or more registered voters)

DESCRIPTION: The current zoning restrictions for non-profit medical cannabis cultivators, processors, and distributors has become outdated and needs updating to reflect the changes in state law regarding all Medical and Recreational Marijuana Establishments. This article seeks to see if the Town will vote to amend if the Town will vote to amend Chapter 135 of the Zoning Bylaw to update the current restrictions.

ARTICLE 44 AMEND THE GENERAL BYLAWS DEMOLITION DELAY AMENDMENTS

To see if the Town will vote to amend Chapter 19 of the Code of Lexington, Demolition Delay, to ensure consistency with the adoption of Neighborhood Conservation Districts, Chapter 78 of the Code (adopted at Annual Town Meeting 2016), make certain technical changes with respect to the Historic Districts Commission legislation, or act in any other related manner.

(Inserted by the Board of Selectmen at the request of the Historical Society and Planning Board)

DESCRIPTION: This Article is to correct an internal discrepancy between Chapter 19, Demolition Delay, and Chapter 78, Neighborhood Conservation Districts, identified after the adoption of Chapter 78. Several amendments to the Demolition Delay Bylaw are suggested to ensure internal consistency between the two chapters. Additionally, references to the Historic Districts Commission Special Act (Chapter 447 of the Acts of 1956, as amended) are modified to refer to any successor governing statute.

Article 45 AMEND CH. 447, MASSACHUSETTS GENERAL LAWS, ACTS OF 1956

To see if the Town will vote to request the Massachusetts General Court to amend Ch. 447, Acts of 1956, as previously amended, as follows:

- (a) amend <u>Section 3</u>, <u>Definitions</u>, by adding a definition of "person aggrieved", and amending the definition of "structure",
- (b) amend <u>Section 4, Creation and Organization of Historic Districts Commission</u>, to add Lexington's Design Review Committee and delete the Lexington Arts and Crafts Society and trustees of Cary Memorial Library as nominating organizations, and add considerations for nominee review;
- (c) amend <u>Section 6</u>, <u>Exclusions</u>, to clarify the process for matters concerning public safety in subsection (a), clarify the process for approving temporary structures and signs, in subsection (b)(1), and delete the exclusion for changes of exterior color to white in subsection (c);
- (d) amend <u>Section 8</u>, <u>Meetings</u>, <u>Hearings</u>, <u>Time for Making Determinations</u>, to clarify the persons who are entitled to notice of HDC proceedings;
- (e) amend <u>Section 9</u>, <u>Powers</u>, <u>Functions</u>, and <u>Duties of Commission</u>, to clarify HDC regulation of new construction and additions and add a policy statement with respect to solar installations; and
- (f) amend <u>Section 11</u>, <u>Enforcement</u>, with respect to continuing offenses;

or act in any other manner in relation thereto.

(Inserted by the Board of Selectmen at the request of the Historic Districts Commission)

DESCRIPTION: Chapter 447, the governing legislation for Historic Districts regulation and review, has not been substantially revised or amended since its adoption in 1956. These amendments are proposed by the Historic Districts Commission to clarify ambiguous terms by expressly defining them (subsection (a) above) and codify longstanding practices of the HDC; streamline and strengthen the process of appointing members to the HDC, ensuring the availability of qualified, willing applicants to serve as HDC members (subsection b)); clarify procedures for review of public safety hazards and temporary signs and structures (subsection (c)); eliminate archaic or redundant provisions (subsection 9(c)); grant more certainty to those entitled to notice of proceedings (subsection (d)) and who have standing to appeal decisions (subsection (a) - definition of "person aggrieved")); conform the scope of HDC review and remedies to standards used by historic district commissions throughout the Commonwealth (subsections (e) and (f)); and recognize the importance of alternative energy solutions (subsection (e)).

AD HOC STONE BUILDING STAKEHOLDER COMMITTEE

Members: Nine, an architect who is a Lexington resident, a museum professional,

preferably with curator experience, who is a Lexington resident, a representative from each of: the Cary Memorial Library Trustees, the Historical Society, the Historical Commission, the Historic Districts Commission, as well as a member of the Lexington arts community and an

East Lexington resident.

Appointed by: Board of Selectmen

Length of Term: Upon completion of all recommendations to the Board of Selectmen in

accordance with the established deliverables schedule as outlined below.

Meeting Times: As determined by the Committee.

A minimum of one evening meeting to solicit public comment shall be

required.

Description: This committee will prepare a feasibility study on the use of the first floor of

the historic Stone Building for lease to museums and historical societies for traveling or rotating exhibits. Prior to advancing further preservation investments recommended in prior Town studies, this committee would ascertain market interest among local and regional arts and cultural groups in utilizing the first floor exhibit space. The committee would research such groups and gauge interest in using the space for rotating exhibitions open to

the public in a manner consistent with the prior reports.

In 2016, the Executive Director of the Lexington Historical Society expressed interest in exhibiting items from its collection, and suggested undertaking a feasibility study that would gauge the interest level of other exhibitors in showing collections and artifacts at the Stone Building. The Lexington Historical Society is not seeking to take on the responsibility for the management of the Stone Building, or for making the Stone Building its archive or permanent museum.

Knowledge, expertise and contacts in the regional museum and exhibition profession is desired on this committee to identify contacts with museums and historical societies, and to objectively survey and report on the level of interest that could reasonably be expected from these exhibitors. Operating the

Stone Building for public use would have associated costs, and the type and degree of exhibitors' rental or lease interest must be gauged to project whether a portion of the operating costs could be covered by lease revenue from exhibitors. This feasibility study will therefore help determine if this use justifies budgeting further preservation upgrades to the building, or if different uses should be contemplated.

Tasks:

- 1) To determine the feasibility and market demand for operating the Stone Building as exhibit space on the first floor. This use appears to be consistent with the uses detailed in the deed. Future use would also have to be consistent with the Secretary of the Interior's Standards for the Treatment of Historic Properties.
- 2) Review the 2010 Historic Structures Report and the 2008 and 2009 Lexington Heritage Center Working Group work.
- 3) To determine the scope of potential interest in paying the Town to rent the exhibition space and mount exhibits by contacting or surveying regional museums, historical entities, and exhibition professionals, including but not limited to the Lexington Historical Society.
- 4) To determine the operating cost of staffing, publicizing and administering exhibits.
- 5) To determine (or update) the capital costs to design and fit out the interior with ADA accessibility/bathrooms and the climate control and exhibition display furnishings (e.g., panels, false walls, display cases.)
- 6) To prepare a report summarizing the market interest and potential operating and capital costs to carry out this use.

Vision:

This use of the first floor was one of the uses recommended in the 2010 Historic Structures Report funded by Town Meeting, and advanced in 2008 and 2009 by the Lexington Heritage Center Working Group. This use is also consistent with the use restrictions on the Stone Building detailed in the deed. If this use is determined to be feasible, budgeting for the recommended preservation work on the Stone Building could be justified, and the future of this landmark building could be more secure.

The Stone Building is believed to be one of the earliest lyceums in America. It was built in 1833, and speakers included Ralph Waldo Emerson, Henry David Thoreau, Charles Sumner, and Josiah Quincy, Jr. The lyceum hall is on the second floor. The Menders Torrey Spencer report recommends that the second floor be used in the future as it was historically, as an assembly room for public lectures and community meetings. The first floor was believed to be living quarters. The recommended uses are consistent with the Secretary of the Interior's Standards for the Treatment of Historic Properties.

Mission: To preserve the Stone Building by researching the feasibility of exhibition

use of the first floor, thereby supporting future Town investment to implement the preservation recommendations of the 2009 Historic

Structures Report.

Deliverables: Report addressed to Board of Selectmen on the feasibility of the proposed use

no later than November 16, 2018.

Criteria for Membership: Experience in preservation architecture, experience and contacts in

museum exhibitions or museum curating and New England regional historical

societies is highly desirable. Experience in administration and financial

aspect of operating a public exhibition space. Familiarity with the Secretary of

the Interior's Standards for the Treatment of Historic Properties.





Responding to Mental Health Needs in the Community

Library Materials -

Library staff are frequently asked for mental health/wellness related resources. We treat these requests like we would treat any other request for information and do our best to connect the patron with the information they are seeking. The library collection includes many titles for individuals looking to learn more about mental health and wellbeing. We have a special "Teen Issues" collection with books specifically for teens.

Library Programs and Services-

Most of the library's programming does not focus specifically on mental health topics, but we have hosted programs that foster wellness - including programs on meditation, stress relief, and other life skills.

Our Teen Services Manager has been very proactive in her work around student stress. Some programs/decisions that reflect this approach include:

- Providing a "tutor-free" zone in the Teen Space, keeping the space more relaxed (and noisy)
- Providing stress relief activities/programs during LHS finals weeks including having a therapy dog on site
- Offering Teens the opportunity to start clubs/activities that engage and empower younger students
- Providing many opportunities for teens to relax work with their hands either on art projects, technology programs, or in a ukulele club
- The Teen Space's Art Wall that showcases student creativity

<u>Library Facility -</u>

The Cary Library is a public building that is free and open to all, and we do sometimes become aware of individuals who are suffering from mental illness. There are, no doubt, many more who do not come to our attention because they are able to navigate the facility within the parameters of acceptable use. We treat these patrons as we would any others - we ask them to modify the specific behaviors that do not adhere to our policies.

Crisis Management -

When crises arise, we reach out to the appropriate entity for support. Depending on the situation, that may be the Human Services Department, the Police, the LPS (School Resource Office, Prevention Specialist, teachers, or others), or to family members of the person in crisis.

The Library's Needs in this Area:

- Ongoing staff training to better navigate our work with the public
- Partnerships that bring mental health/wellbeing programs to the library

Fire Department

The Fire Department is one of Lexington's first responders, as such we often have initial contact with people having mental health issues, whether they are in full blown crisis or show the signs and symptoms, we use our training to see that these people get the help they require. Sometimes this involves transportation in the ambulance to an appropriate facility and other times it may be a simple referral to a program specific to their needs.

When folks call us they are inviting us into their home, it may be for an emergency or for an inspection, and during this visit we perform a visual inspection into how these people live out their day. We look for signs of hoarding, malnutrition, and over medication to name a few. If we identify something that looks out of the norm, we may address it with the individual that we have contact with, or we may refer this person to the Human Services Department for a follow up. As mandatory reporters if we feel that there is some type of an abuse situation happening we will report it to the State.

Training

All of our firefighters have mental health crisis training as part of our EMT/Paramedic recertification refresher training. We are taught to identify people heading towards a crisis, possible triggers and how to avoid them, and talking people down from a crisis. One of the most important part of the training is knowing our limits and that our brief encounter with these people will in no way cure them. Most people suffering from mental health issues require long term assistance.

Departmental Collaboration

We have monthly meetings between us, the police and human services departments to discuss "at risk" people. During these meetings we compare notes on individuals so that we may intervene prior to a problem becoming worse. The schools are represented through the police resource officer. Many times we find that several of the departments might know an individual through separate contacts. Unfortunately we still have people fall through the cracks, with four different working shifts we may visit the same person on multiple occasions and not seeing the connection right away. We have tried to better communicate internally to prevent this from happening.

Typically we have seen an escalation of people who are having difficulty getting the help they need, whether it be due to insurance constraints or lack of practitioners we don't know.

Lexington Office of Public Health, (LOPH)

Services that are currently available:

- Medical Waste Collection
 - o LOPH offers walk-in drop off of unwanted medicines and medical sharps during business hours
 - o 4 Medical Waste Drop Off events each year.
 - o (New in 2018) 24 hour access to medical waste and sharps kiosks outside of TOB.
- Mental Health First Aid Classes
 - O LOPH has sponsored both Mental Health First Aid (MHFA) and Youth Mental Health First Aid (YMHFA) to the general public, LPS teachers and staff, and concerned parents. Several grant opportunities from CHNA-15 have focused on providing these classes at no cost to the participant.
- State Sanitary Code Enforcement
 - O LOPH conducts State Sanitary Code Inspections (when invited into the dwelling by the occupant or an administrative search warrant issued by Concord District Court) for homes in deplorable condition. Homes in deplorable conditions are sometimes inhabited by residents with mental health issues. Code enforcement inspections are sometimes the first step in allowing other social service agencies to offer services related to mental health and other home care services.
- Participate in Monthly Task Force Meetings
 - O LOPH, along with Police, Fire, Human Services and other departments participate in monthly interdisciplinary "Task Force" meetings are a way to share critical information about complicated cases (situations where residents may be at risk to lose their housing) are discussed and interdepartmental collaboration is utilized for the benefit of the resident.

Unmet Needs for Mental Health:

- Hoarding Clean-up
 - Oftentimes a homeowner lacks the funds to adequately clean up their home after their home has been deemed Unfit for Human Habitation by the Board of Health. In cases like these, a lien may be put on the property, or the resident may be at risk for losing their housing
- Services for those under 60 Years of Age
 - Residents under the age of 60 years who are in a hoarding situation do not have access to the same level of services available to those who are over 60 years and able to access Senior-related social services.

Mental Health Services Lexington Police Department Chief Mark Corr

The Police Department's role as a first responder within the community results in numerous interactions with individuals with mental health issues. The different scenarios are too numerous to list and may involve low level motor vehicle encounters through intense encounters whereby a person is violent and threatening public safety. Police officers and Dispatchers are often the first to identify or interact with someone who needs mental health services. The Lexington Police Department has taken the International Association of Chiefs of Police "One Mind Pledge" whereby 100% of the Police Department will be trained in mental health first aid within 36 months with 20% trained in crisis intervention. Other services include:

Patrol and Dispatch

- All officers/dispatchers receive mental health response training in the academy and in-service

- Advocates; 24-hour emergency psychiatric services in Waltham MA
- RMV immediate threat screening for motorists

Detective Bureau

- Family Services Detective; handles all domestic issues including disputes, violence, runaway and self-destructive behaviors
- Community Resource Detective; offering crime prevention and recovery services; youth programming and safety initiatives
- School Resource Officer; weekly meeting with school deans; Youth Commission liaison; ALICE training; LHS Criminal Justice club; safety awareness and liaison with student population
- Suburban Middlesex County Drug Task Force Detective; helping to identify drug issues in Lexington and the region; training on drug trends and general substance abuse awareness training
- Police Prosecutor; identifying individuals with mental health or substance abuse issues so as to divert from criminal justice system or use court ordered services such as Chapter 123, Section 35 (30-day confinement for alcohol abuse).

- Domestic Violence Service Network; serving the community where mental health may manifest itself
 in child abuse, domestic violence, and elder abuse; Central Middlesex Assessment for Safety Team
 (CMAST) for high risk offenders
- Communities for Restorative Justice (C4RJ); alternative to criminal prosecution (youth and adults)
- Department of Mental Health; checks before issuing firearms

Lexington is not immune to the mental health issues in the region. Those that come to the attention of the Police Department and require continuing attention are:

- Alcohol, marijuana, prescription and other drug use and abuse
- Risks to aging community including dementia, Alzheimer's, hoarding and those who are house bound
- Domestic abuse
- Low frequency (in Lexington) / high risk matters: homelessness, opioid overdosing
- Fraud, ID theft, computer crime targeting elders / disabled
- Growing number of group homes and intermediate care facilities in Lexington; potential for lost or wandering individuals
- Increasing use of social media by individuals with mental health issues and locating these individuals after troubling posts
